

**LAS VEGAS INSURANCE PROFESSIONALS
REGIONAL CONFERENCE PARTICIPATION SCHOLARSHIP
Evaluation Period: 1/1/09 – 12/31/09
Attendance Year: 04/10**

Purpose:

To provide a deserving member, who has not had the opportunity to attend a Region VIII annual conference, with financial assistance to attend the Regional Conference. It is LVIP's opinion that attendance at a Regional Conference allows members a broader view of NAIW and is instrumental in their growth as members. The recipient will provide members with a post- conference report at the 1st general meeting after the conference to describe their experience and what benefit they received by attending the conference.

1. The Executive Board, at the time of budget setting will determine the amount of the scholarship to be awarded during that budget year.
2. The Awards Committee Chairman will assign a committee of no less than 3, no more than 5 members to review the submitted applications and determine a recipient.
3. Submissions must be received by the Awards Committee Chairman by end of day January 15th. Submissions will be via email.
4. The Awards Committee Chairman will email the submissions to the committee members within 2 working days of the deadline.
5. The committee will submit the results to the Awards Committee Chairman by end of day February 15th.
6. Awards Committee Chairman will publish the results within 5 working days to allow ample time for registration for the conference.
7. Members who have already attended a Regional Conference are not eligible. Once a member has been a recipient of this scholarship, they are no longer eligible.
8. Each email entry shall consist of:
 - a. Members name
 - b. Date member joined LVIP
 - c. Declaration that they have never attended a Regional Conference
 - d. A paragraph explaining why they want to attend the conference and what benefit they feel they will get from attendance
 - e. Completed, attached tally form
9. Agreement that they will provide the post conference report to membership
10. The committee will review the entries, verify the data and assign appropriate points
11. The scholarship will be blasted to all members and awarded at the March meeting
12. The points are awarded as follows:
 - a. Five (5) pts for regular meetings attended - 10 meetings / 50 points max
 - b. Ten (10) pts for attending the state meeting - 1 state meeting / 10 points
 - c. Ten (10) pts for each LVIP sponsored CE class- no maximum
 - d. Ten (10) pts for Executive Board position - can hold 2 during the year
 - e. Five (5) pts for Board of Directors position - can hold 2 during the year
 - f. Ten (10) pts for Committee Chair positions - no maximum
 - g. Five (5) pt for serving on a committee - no maximum
 - h. Five (5) pts for NAIW classes taken - no maximum
 - i. Five (5) pts for each new member recruited - no maximum
 - j. Twenty (20) pts for community action activities - maximum 2
